Booth workers may attend exhibitor functions only, from Wednesday night to Friday at 12 noon. Booth workers are not eligible to take part in the golf tournament or other optional events. Only full convention registrants may participate in these events.</p>
<p><b>Assigning Booth Space:</b> Booths will be assigned after payment is received. Booths will likely be placed along the outer edges of the exhibit area.
